- The Pakhribas Municipality has allocated funds towards the cost of road upgrading works and intends to apply part of
 the funds to cover eligible payments under the Contract for Dharmashala- Mansichautara- Gambhire- RayaghatBhojpur Agricultural Road Upgrading Project (Ch.0+000 to 6+580). Bidding is open to all eligible as per
 Section V of bidding document.
- Pakhribas Municipality invites sealed bids or electronic bids from eligible bidders for the construction of Rigid Pavement, Side Drain, Sub-Base Works and cross-drainage works under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 3,92,00,000.00
- Minimum Work experience of similar size and nature: Participation as Prime contractor, management contractor, or subcontractor, in at least One (1) Contract within the last ten (10) years, with a value of at least NRs 2,09,00,000.00 that have been successfully or are substantially completed and that are similar to the proposed works.
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed
 envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed
 envelope as per the provision of ITB 21 of the Bidding Document.

The bids will be opened in the presence of Bidders' representatives who choose to attend on 13:00 Hrs of 16th January 2023 at the Pakhribas Municipality, Office of the Municipal Executive, Dhankuta, Province No-1. Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 660,000.00 which shall be valid for 30 days beyond the validity period of the bid.
