The Pakhribas Municipality has allocated funds towards the cost of Jaldevi Simsar Park and intends to apply part of the funds to cover eligible payments under the Contract for Jaldevi Simsar Park Nirman Tatha Samrakshan Works, Contract ID: PKBSMUN/NCB/WORK/2077/078-10. Bidding is open to all eligible as per Section V of bidding document.
2. The Pakhribas Municipality invites sealed bids or electronic bids from eligible bidders for the construction of Arch Bridge, RCC Retaining Wall, Foot Trail, Entrance Gate, Traditional Chautara, Park Area and Toilet Block under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 3,00,00,000.00
  - Minimum Work experience of similar size and nature: NRs. 4,65,00,000.00
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Electronic bids must be submitted to the office Pakhribas Municipality, Office of the Municipal Executive, Pakhribas, Dhankuta through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:Hrs on 18th April, 2021. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend on 13:00 Hrs of 18th April 2021 at the Pakhribas Municipality, Office of the Municipal Executive, Dhankuta, Province No-1, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 17,00,000.00 which shall be valid for 30 days beyond the validity period of the bid.
